The following is the local educational agency’s (LEA’s) plan for providing supplemental instruction and support to students, including those identified as needing academic, social-emotional, and other supports, including the provision of meals and snacks. Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

The District Advisory Committee (DAC), District English Learner Advisory Committee (DELAC) and LCAP Survey responses specifically related to needs associated with the Covid pandemic; all provided feedback in the development of the Expanded Learning Opportunities Grant Plan. In addition the Reopening Schools Task force created by the District Superintendent, along with the subcommittees of Health and Safety, Curriculum and Instruction, and Communication provided important feedback in the development of the plan. Each of the subcommittees contained representatives from each stakeholder group: parents, students, teachers, classified staff members, and administration.

A description of how students will be identified and the needs of students will be assessed.

Students must first be assessed in order to meet their identified needs. To assess student learning needs, District schools will review initial and benchmark assessments in reading (Nelson/Denny reading screening and/or Read 180), math (Math 180 and/or ALEKS) and ELD (Cengage and/or ELPAC Summative Test or similar tests) Using the same or similar assessments, District schools will test students at the beginning of the 2021/22 school year and each year thereafter until 2024 to determine learning needs. Benchmark assessments will be administered throughout the year and the results will be compared to previous years to assess student recovery of learning. Additional information will help assess learning needs specific to ELs, Foster and Homeless youth, low income, and students with disabilities: Teacher referrals via "Concerned Students" form, Student Intervention Team meeting notes, Informal assessments in ELD classes, and progress reports for students with IEPs. In addition, the District will contract with outside agencies like Lindamood-Bell to provide ongoing assessments and intervention in reading, Read 180, Math 180 for students who have fallen behind in math skills, and ELD enrichment boot

camps. Instructional staff will receive professional development designed to use the data that will result from the assessments mentioned and design lessons that will address identified learning loss of their students, especially in the first several months of the school year.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and Guardians of students who are eligible to participate in opportunities for supplemental instruction and support will be informed primarily through site-based communication and also through supplemental communication from the various district departments that support the implementation of the programs and services. Parent-Teacher Association (PTA) meetings and other parent leadership groups will be informed of the supplemental instruction and support offerings as well as on District and school websites and through principal newsletters. Social media will be utilized by the various schools to promote and inform students, parents, and even staff members of the services available to students. Counselors will be informed so that they can better advise students as to the supports that will be best suited to meet their needs.

A description of the LEA's plan to provide supplemental instruction and support.

The district plans to provide supplemental instruction and support through the following actions: 1. Extending instructional learning time beyond what is required for the school year. This will include summer school and before or after-school tutoring programs. This will enable staff members and outside agencies to work with students in small group settings to provide direct academic support. 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports will be provided via dedicated staff members and/or contracted support providers who will be responsible for monitoring and coordinating all intervention efforts for students below grade level as well as leading small intervention groups. 3. Additional technology will be purchased that can be used to provide more hands-on learning for students returning to school and increased storage of student's digital portfolios. Support staff dedicated to educational technology and its continued integration into 21st-century learning will evaluate and filter the best educational technology from the myriad software tools on the market and will support the integration of existing and new technologies into classroom instruction. 4. Integrated student supports to address other barriers to learning, such as the increased provision of guidance services, mental health services, interpretation/translation, and health services. 5. Professional learning through internal (teachers on special assignment and instructional aides) and external (educational support agencies) experts to provide training on best practices to accelerate learning. 6. Support staff to ensure the safety and health of students returning to schools such as custodians, nurses, and nutritional services. 7. Administrative clerical personnel to support the additional supplemental instruction and support services and service providers.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The District included AB 86 funding from the In-Person Instruction Grant and the ELO Paraprofessional funding in the development of the plan. As services are evaluated for effectiveness and need, the District expenditures to expand learning opportunities will be extended

beyond just one to two years by utilizing ESSR II and ESSR III funds to continue providing the supports outlined in the ELO grant plan up to four years so that students entering high school will receive these supports through their tenure in the District.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
